# REGIONAL BALL DIAMOND USER BEHAVIOUR GUIDELINES

We want to ensure that you have a safe and positive experience at this facility. Your adherence to these guidelines is key to ensuring that this facility remains open to the public.











#### **USER** CONDUCT



- · Profanity, aggressive and disrespectful behaviour from officials, facility staff, players, coaches, or spectators will not be tolerated. This extends to an individuals conduct online with regards to ball diamond use, whether from or directed at officials, facility staff, players, coaches or spectators.
- Spitting (including sunflower seeds) is prohibited. Please help keep the facility clean and sanitary for all user groups.
- Users must vacate dugouts in accordance with the facility's policy.
- · Pets must be on a leash and are not permitted to be within 5 meters of the playing surface.
- · Please refer to the provincial sport and recreation guidelines for more information.

#### **USE OF RECORDING DEVICES**



Use of personal recording devices such as smart phones, tablets, cameras etc. is permitted within the following guidelines only, and content obtained is not for commercial or distribution purposes:

- Photo(s) or video(s) include members of your family or group only.
- Express permission is granted from other public participants featured in the recording. Be conscious of others who may be in the background of your recordings.
- · Use of recording devices within any facility washroom, changeroom and/or dressing room is strictly prohibited.

#### **CONTROLLED SUBSTANCES** (ALCOHOL & **CANNABIS**)

- · This facility adheres to Alberta's Tobacco, Smoking and Vaping Reduction Act, the Gaming, Liquor and Cannabis Act as well as local bylaws regarding the use of controlled substances such as cannabis, tobacco and alcoholic beverages in a public space.
- · Alcohol is not permitted in the facility unless specifically approved in writing and subject to compliance with applicable regulations.
- · Guidelines include the ball diamonds, dugouts and spectators within the facility. Consumption of alcohol in these facilities without written permission could result in personal fines.
- Smoking tobacco products, vaping or consumption of cannabis is strictly prohibited in the facility, ball diamonds and dugouts.

### **BANNERS.** SIGNS &



- Signs, posters, clothing or messages with explicit language, profanity or derogatory characterization directed toward any person or groups are prohibited.
- Signs cannot be posted in or attached to the facility without prior approval.

## **FOOD AND**



- · Food is not permitted on any playing surface.
- Glass containers are prohibited. This will protect maintenance crews, and user groups, especially youth programs, from coming in contact with broken glass.
- All users must honour all food service contractual arrangements specific to the facility.

The facility renter is responsible for the conduct of participants and spectators as well as ensuring that all users adhere to the facility booking process during the rental period. The facility staff are responsible for the operation and general supervision of the facility and shall enforce these guidelines. Non-compliance of these guidelines may result in loss of booking privileges and/or removal from the facility. Police or Enforcement Services will be contacted if necessary.
